What about going to a local police station and having them look for it? Or the local small claims court? I mean, it's probably not going to cost much to have someone (a Judge, for example) look at the car (and print out a subpoena/summons), and you could ask them to look (by way of them notifying the car's owner) to see if its been reported stolen. That being said, if there is really no significant damage (from the accident) they will most likely tell you it was an unavoidable accident and let it go. Either way, I'm sure that you will get the car back in the end, but unless there is any significant damage, you're pretty much out of luck if you try to pursue it further. You

will also need to find out what the insurance company said about the accident, and give them a call and let them know that you want to pursue the claim in small claims court.

That being said, I'd still advice against it if your car is in the city of Toronto, and you're really not familiar with the courts in that city. Any more questions or concerns? I'm sure my

answer will help you understand why it doesn't really make sense to do the small claims court route with regard to your case.
